**Report of the Director of Legal Services and Partnerships**

1. Purpose of the Report and Summary

1.1 The report sets out the details of applications received for Crime Prevention funding to enable the Committee to make determinations on those applications.

5. Background

5.1 By a decision of the Leader of Council dated 26 October 2022 the Leader of Council established the Crime Prevention sub-committee as a committee of the Council's Cabinet and delegated a capital budget of £250k to be committed by the committee as grant funding to communities to support them develop community safety solutions in their neighbourhoods. Further funding was awarded in 2023-2024 (£250,000), 2024-2025 (£500,000) and 2025-2026 (£400,000)

5.2 In order to ensure that the funding is of wide-ranging benefit across the city grants are available in the following categories:

(a) Small grants £500-£5,000 (anticipated allocation £50,000)

(b) Medium grants £5,001 £15,000 (anticipated allocation £100,000)

(c) Large grants above £15,000 £25,000 (anticipated allocation £100,000)

5.3 The Sub Committee for Crime Prevention Fund agreed eligibility criteria for award of grants, this is detailed at Appendix 2.

6. Issues for Consideration

6.1 **Crime Prevention Fund (CPF) Budget**

The following figures reflect the 2022-2026 CPF capital budget allocation and the sum available prior to the consideration of applications tabled at this meeting:
